This contract is between Mill Creek Marine Inc and referred to herein as "Yard" and the boat owner referred to herein as "Owner".

1. Storage fees are figured on the total length and beam of the boat and trailer including outdrives or outboards, swim platforms and bow pulpits. Rates do not include power washing, hauling, blocking and spring launch.
2. Rates are as follows:

Outside Storage: \$24.00 per linear ft.	Haul and block over 32' \$11.00/ ft.
Haul and Block \$11.00/linear ft. (incl. blocks and stands)	Shrinkwrap – boats up to 22' \$20.00 per linear ft.
Inside Storage on floor: \$7.00 per square ft.	Shrinkwrap – boats over 22' \$22.00 per linear foot
Inside Storage on Rack \$6.00 per square ft.	Sailboat mast in: \$4.00 per linear ft. additional
	Pressure washing: \$5.00 per linear foot
3. No person other than Yard personnel will be permitted to prepare for winter storage or shrink-wrap any vessel in the Yard.
4. All boats stored by the Yard will have the bottom pressure washed
5. 50% of the total storage bill is due with the agreement and the balance will be billed in January. Storage deposits are non-refundable.
6. Storage includes blocking and stands. It does not include shrink-wrapping, winterization, storage of engines, outboards, outdrives, batteries, trailers or spring commissioning and launch.
7. All mechanic labor is billed at \$110.00 per hour and all yard labor is billed at \$88.00 per hour.
8. It is important that all boats be turned over to us by November 15th. Additional charges resulting from freeze damage may be avoided in this manner.
9. Please contact the Yard prior to dropping your boat off for service and/or storage. Boats must have clearly marked fenders and docking lines onboard if we are hauling or launching the boat. If these items are not onboard, they will be provided by us and billed. The Yard is not responsible for fenders, lines, boat covers, tie downs or any other personal items.
10. Boats, engines and outdrives that are not picked up within two weeks of service billing will be stored and billed accordingly. Trailers not picked up within two weeks of spring commissioning will be stored and billed at the current rate. There is no pro-rating of any fees.
11. Any covers not properly secured on boats stored outside will be secured by the Yard at the Owner's expense.
12. The Winter storage season is from 10/15-4/15. Any vessels not launched by June 1 will be subject to a summer storage fee commencing 4/16.
13. All bottom sanding and painting must be done by Yard personnel.
14. For environmental reasons all vessels MUST use non-toxic antifreeze provided by the Yard.

15. Due to unpredictable weather conditions and high demand for spring deliveries, the Yard cannot guarantee launch and delivery dates, are on a first come-first served basis and 2 weeks notice of the requested delivery date is required. We will make every effort to deliver your boat according to your wishes.
16. All batteries must be disconnected once a boat has been winterized. Boats cannot be left plugged in due to the significant risk of electrical fires.
17. Living aboard boats on the premises is prohibited
18. Owner agrees to comply with the above terms and acknowledge that the vessel will be handled and stored at Owner's risk. The Yard will not be responsible for theft, vandalism or damage from wind, fire, floods, etc and in any event, the Yard's total liability is limited to \$10/ft. With the exception of gross negligence on the part of Yard, Owner waives and releases all claims against the Yard. In addition, Owner agrees to indemnify and hold harmless Yard from all damages and liability, including third-party claims, arising out of this Agreement or out of any acts or omissions by Owner or Owner's agent. Owner's indemnity obligations include, but are not limited to reasonable attorneys' fees and costs of defense of such claims. Owner declares that they have adequate property and liability insurance coverage for all losses to their boat and surrounding property of others.
19. I/We authorize Mill Creek Marine, Inc. (MCM) to keep the credit card listed below on file. It is my understanding that payment is due upon pick up, at which time I may elect to use an alternative form of payment. If invoices are not paid within the 10-day terms, I/we authorize MCM to charge any overdue balance to the credit card on file. It is my understanding that by authorizing MCM to charge my credit card over the phone, I/we are in acceptance of all expenses rendered for work performed by MCM.
